

Members who choose to earn awards may do so by <u>fulfilling and documenting the requirements</u> on page two for the year in which the title was earned. *Special circumstances, such as contributing to the club by doing activities not listed in the requirements, will not exempt members from completing all requirements*. **All requirements must be met.** This form will keep track of your requirements throughout the year.
