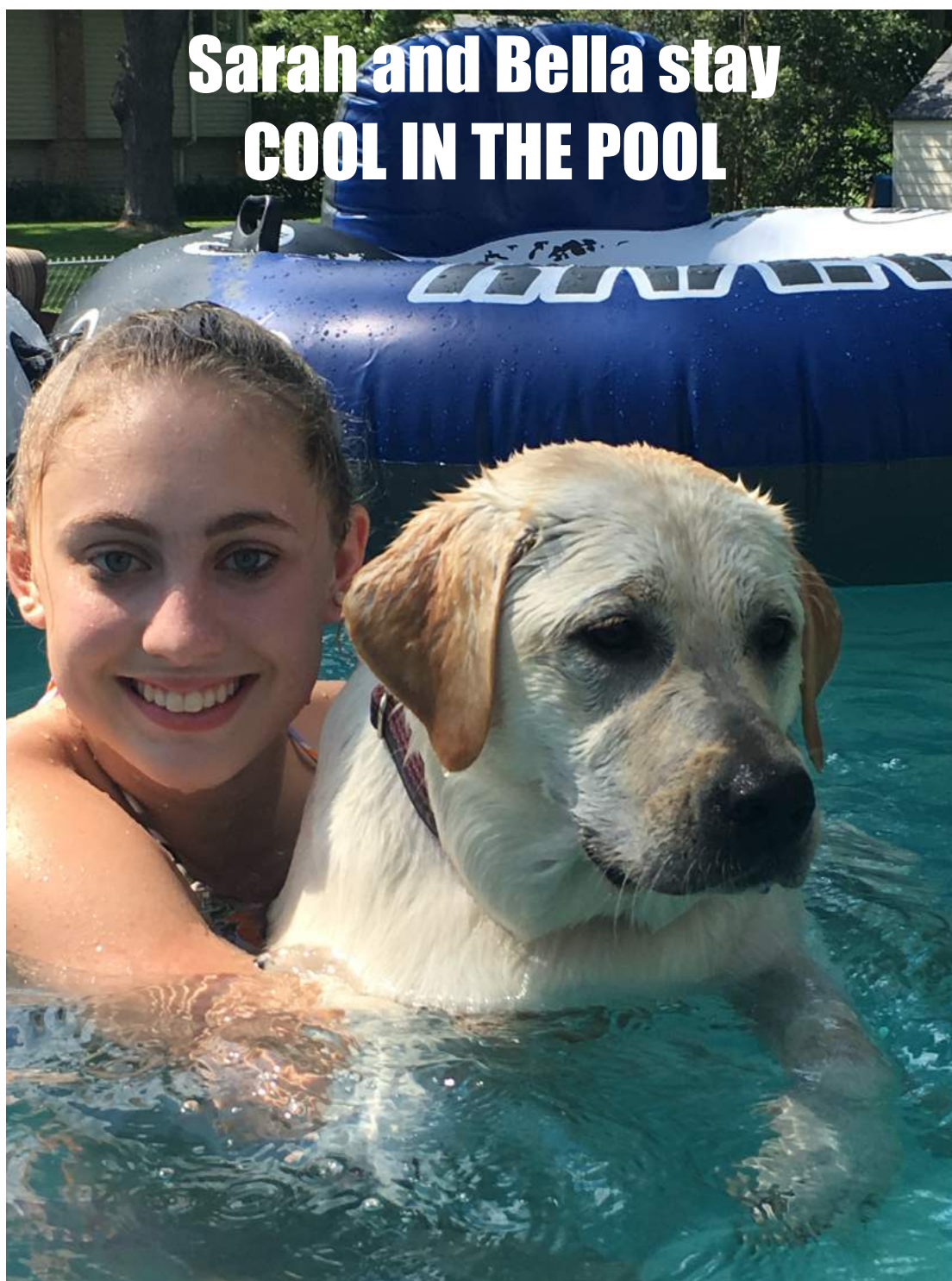

PRESIDENT'S REPORT by Jim Clarke



Have you ever considered that August is a month of change? Think about it! The summer is almost over, days are getting shorter, kids go back to school; and with our month off, we are pumped and ready to return to our normal Monday and reenter the ring for drop-in training. In just a few months the fall trials will be in full swing. It's time to start thinking "titles!"

As I wrote in the July President's report, we have new **"stuff"** happening in our training rings. Once again I have to thank **Puppy Class Instructor, Cheri Nicholas**, for incorporating **AKC S.T.A.R. Puppy** instruction into our already existing puppy class. Cheri will be changing the class to comply with the **AKC S.T.A.R. Puppy program**. This program includes introduction to the exercises required to pass the AKC Canine Good Citizen (CGC) exam. Not only did Cheri become certified to teach S.T.A.R. Puppy, she ordered all of the teaching materials and is ready to begin on August 6.



Additionally, I am excited about what is happening in our two Beginner Classes. Instructors **Francis Soresi, Tom Stephenson, and Joanie Wisniewski**, have worked over the summer to revamp both Beginner classes to include CGC materials. The idea is to enable someone who takes our classes to pass the CGC exam and get the official AKC title. At some point we will be offering the Canine Good Citizen exam. **Thank You so much Francis, Tom and Joanie**. The new 6:45 Beginner Class will start on August 6 and the new 6:00 Beginner Class will start on September 17.

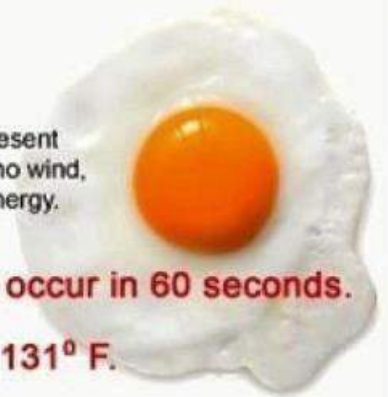

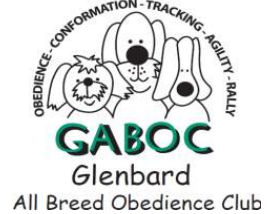

GENERAL MEETING MINUTES

June 22, 2018

PRE-BOARD MEETING:

A pre-board meeting was called to order at 7:04 p.m. Jim Clarke submitted one membership application for Board approval.

A motion was made by Bette McMillan and seconded by Bob Melka that the above named person be voted into membership. Motion carried.

Pre-board meeting adjourned at 7:05 p.m.

SECRETARY'S REPORT

The minutes of the General Membership Meeting of April 27 were read. A motion was made by Sheila Gardner and seconded by Karen Schlipf that the minutes be accepted as read. Motion carried.

A note from tracking judge, Jane Jonas, was read. Ms. Jonas thanked Darlene and John Barnard for their hospitality at the June 9 Night VST test.

PRESIDENT'S REPORT

1. Jim Clarke reminded everyone that our annual picnic was going to be held at the fairgrounds on Monday, June 25; and, that it was the last day for training until August.

VICE PRESIDENT'S REPORT

1. Jim Clarke read from the Bylaws -- Article V: Section 7, Vacancies: *Any vacancy, other than the office of President, shall be filled by majority vote of the remaining officers and the Board of Directors, for the unexpired term of such office and then presented to the membership for approval.*

The Board recommended that Liz Hixon fulfill Donna Darland's remaining term as Vice President. Jim called for a vote of the membership. The General Membership voted to elect Liz Hixon as Vice President. As Vice President, Liz Hixon's first order of business was to submit the name of Gail Meyers into membership.

A motion was made by Bette McMillan and seconded by Bob Melka that Gail Meyers be accepted into membership. Motion carried.

TREASURER'S REPORT

1. Donna Eichman reported that our fiscal year is half over. She did a comparison of our mid-year loss between 2016, 2017, and 2018. Mid-year 2016 we were down \$2,237.00, 2017 we were down \$4,503.00; and, so far in 2018 we are at a net loss of \$5,304.62.
2. The difference between 2017 and 2018 is due to expenses up 1.4% and income down 6.9%.
3. The June and October Agility Trials are a good source of income and should put us back into the black.

DIRECTOR OF TRAINING

1. Jim Clarke reported that we will not have Early Training (3:00-5:00) during the month of August. Early Training will resume in September. Several reasons for the decision are:

- Attendance at August Early Training is very low.
- Dick Schaefer is retiring and will not be available to assist with Early Training nor will he be instructing the Novice II class.
- Because the Clarkes will be out of town, Bette McMillan would be the only one available to set up 2:00 Rally ring,.

2. Sheila Gardner and Bette McMillan will be instructing the 6:00 Novice II class.

3. Jim thanked the instructors for their hard work. Jim also said that he is putting together a file of people who might want to instruct, assist, or substitute. He distributed the new form and suggested that those people interested fill it out and return it to Jim. The form can also be found on the website.

4. Jim said that GABOC will be offering a S.T.A.R. Puppy class that will begin in August. Cheri Nicholas has become qualified to teach S.T.A.R. Puppy. Puppies who pass her class will get the title and will be prepared to move on to CGC training. Also, our Beginner Class instructors will now be incorporating CGC exercises into their weekly lesson plans. Dogs who graduate from the Beginner classes should be able to be tested and become CGC certified. Occasionally we will find a way to offer the CGC evaluation.

5. Dawn Parison asked if the club would pay for someone wanting to become certified as a CGC instructor. Jim said that we would.

Member Highlight~

Karen Heitz

Hello Everyone:

My name is Karen Heitz. It was a wonderful surprise and honor to be asked to become a BARKS Highlight Member. I asked if they made a mistake since I have only titled one pet and live a quiet life in suburbia with my husband and pet.

Ray and I just celebrated our thirty-fourth wedding anniversary and are blessed with one child teaching in New Orleans. Also, we have an amazing Doberman named Chino, a German dog with a Spanish name. Chino has become an important part of our family and I would like to share a brief portion of his life with you.

Adopting a Doberman was always one of the items on my Bucket List. Unfortunately, we were unable to make the commitment until I retired. With excitement and happiness, we brought a two-year-old Dobe into our family from Illinois Doberman Rescue named Chino. Soon we realized he suffered from severe health issues and had very limited obedience and socialization skills. Immediately, we called a trainer for an in-home evaluation, and she recognized the problem to be fear. She explained that few pets are true Alpha dogs and often fear and aggression issues are confused.

We were eager to start training. When we entered her studio, Chino was overwhelmed. His head went down showing full teeth and his tongue and ears went back causing hysteria in the class. The reaction caused Chino and me to spend the entire ten-week session in seclusion. When the training teams passed the restricted area, they would accelerate their pace and act like Chino was getting ready to lunge.

Behind the fence we worked quietly with toys, balls, treats, and bones to help keep Chino focused and enjoy the experience. The goal was to build a working partnership based on trust. Everyone in class was very professional, and not a single person complained or suggested we take drastic measures.

Ray and I promised Chino that we would help him through his difficulties. Daily, we walked for miles and trained with a double collar and a leash tied to my waist for safety. With positive reinforcement, love, persistence, and patience we completed our CGC after two years of constant training. The trainer and I cried, and she still considers Chino to be one of her greatest training accomplishments.

Chino was ready for the next training level. We became involved in canine exercise, Rally, and Obedience classes. We watched Agility from a distance to familiarize him with fast moving objects. Soon our trainer invited Chino to attend to her class play dates for small to medium size pets. We went on pack walks and sat on benches while asking people to toss Chino a treat as they passed. Ray and I did everything possible to help him become more successful.

Suddenly everything clicked!!! Chino earned his Rally Excellence title, and his Preferred CDX title in Obedience. In 2016, Chino met the eligibility requirements to enter the AKC Rally Championship in Tulsa, OK! He became an Ambassador to promote rescue and the breed and marched in the DPCA Parade of Rescues to proudly represent IDR.



One of my greatest pleasures is when someone says, "I cannot believe Chino is the same dog." I just smile and use it as motivation for the next step. Currently, Chino is working on becoming a Utility Dog and getting ready to compete in the spring.

Ray and I kept our promise to Chino and he is a healthy and happy Obedience pet! He continuously wants to work and be my constant companion. Chino has given more of himself than we ever thought was possible and our experiences surrounding him will always be treasured. Because of our adoption we have made incredible friends and learned exciting new things. We have also met doctors and trainers that have shown a genuine interest in our success. Chino has shown Ray and I love and pride on an unprecedented level making our family's bond much stronger.

Summer Beach Tips for You and Your Dog

Spending a day at the beach with our canine companions can be the perfect way to spend a sunny summer day. Our dogs often enjoy the sand, warmth, and the ocean as much as we do, but there are a few important things to keep in mind when traveling to the beaches with our canine friends to avoid injuries, overheating, sickness or violating local beach regulations.

- Be sure to provide a shaded area for your dog.
- Give him or her plenty of access to clean drinking water.
- Make sure your dog can swim and is familiar with the doggie paddle. Making sure they are able to swim and can handle the exertion is key.
- Dogs can get sunburn, especially those with shorter hair, pink skin or white hair. There is a type of pet-safe sunblock that can be used but be sure it is the kind made specifically for dogs. You can apply this to the ear tips and nose prior to sun exposure.
 - Pet Guard Gel with Sunscreen is a good product to use. Other suggested sunscreen products can be recommended by your **veterinarian** or found at your local pet stores such as Concord Pet.
- Be aware of the ocean water conditions: Are there lots of jellyfish on that given day? Is the current strong? These things can affect your dog's ability to come in and out of the water or may cause unnecessary stings!
- If your pet is out of shape, overweight or has specific health concerns do not encourage him/her to run in the sand. It is great exercise for them to run on the beach, however, a dog who is out of shape can easily injure a ligament or tendon.
- The cool ocean water can be tempting for dogs to drink. Be careful to not let them drink too much salt water as it can cause upset stomachs and other issues.
- Eating sand can be appealing to dogs as well. Be sure not to let them engage in sand eating since it can cause impaction of the bowels.
- Salt and other minerals that are found in the ocean can be harmful or irritate your dogs' coat. Once you are done at the beach for the day be sure to give them a fresh bath once returning home.
- Check the local ordinances before planning your day at the beach with your dogs as not all beaches allow pets.
- Swimming is also a great means of exercise but don't let your dog overdo it. Too much swimming can generate soreness or dehydration. Be sure to have them rest in the shade frequently during the warm to hot summer days.
- Remember to bring pick up bags with you so you do not leave a mess on the beach.
- Be sure your dog is up to date on **vaccinations**, especially if the beach is a common dog-friendly beach where they will interact with other dogs.
