- 4. Tracking: Darlene Barnard reported that the April 21 & 22 TD/TDX Test went well.




- 3. Kathy Bianchetti asked who the Chairman of the Board will be. Jim explained that would be determined at the Board meeting.

- Be sure your dog is wearing a visible and up-todate ID tag on her collar before the party begins.
- Keep charcoal, matches and lighter fluid away from your dog.
- Consider keeping your pup on a leash so she doesn't explore hot grills or tables of food.
- While grilling, ask guests to play with your dog far from the flames.
- Place citronella and other insect-repellants where your dog can't reach them.

- Never leave alcohol unattended around dogs.
- Check that all sunscreen or insect repellant you apply to your dog is labeled for use on pets.
- Don't let guests give your pup people food.
 Consider having a bag of treats on hand.
- Be sure all children are supervised when near your dog to avoid any roughhousing.
- If your pup seems overwhelmed, bring her inside and put her in a quiet area away from guests.






TEACHING YOUR DOG TO WALK POLITELY ON LEASH

PART ONE: Start in a small, boring space. Go at your dog's pace.

The most important step in teaching your dog to walk politely on leash is showing your dog where you want him to be while he is on leash.

To make things easier for your dog, start practicing in a small, boring space. This improves the odds that your dog will stay close to you.




PRACTICE WITH NO DOG

Practice clicking and feeding a treat at your pant seam, at the level of your dog's head.

PRACTICE WITH DOG


Practice holding the leash at your bellybutton as you click and feed.




Click and treat rapidly a few times in the correct position.



Move slightly out of heel position and wait for your dog to move closer to you.



As soon as your dog moves even the tiniest step closer to you, click and feed at the "ideal" head position.



Repeat until your dog moves into heel position every time you move out of it.



Gradually take more and more steps between clicks and treats.

If your dog gets confused, go back to just one step and then increase the number of steps more slowly to help him understand.







Next, move to a larger or more interesting space, and start over from STEP (1)

When your dog can handle STEP 6
in the new space, move to another
new space, starting over
from STEP 1 again.

Then start changing direction and speed.

Teach Your Dog To Be Home Alone


5 STEP TREATMENT PLAN FOR SEPARATION ANXIETY

Teach your dog the meaning of the word "bed"

- 1. Throw a treat into your dog's bed as you point to it and say "bed!"
- 2. Only say "bed", nothing else.
- 3. Repeat at least 10 times, praising calmly when the dog goes to their bed.



- 1. Regularly throw treats into your dog's bed without them seeing.
- 2. Calmly praise and sometimes pet your dag whenever it is in its bed.
- 3. Send your dog to its bed 20 times a day with a "bed" cue.



- 1. Throw a treat into your dog's bed as you point to it and say "bed!"
- 2. Calmly praise so they remain in their bed.
- 3. If the dog gets up within 10 seconds, stop praising and ignore it for 2 minutes.
- 4. Start the whole plan again until the dog remains on the bed when you walk away.



- 1. Send your dog to their bed: "bed!"
- 2. Calmly praise the dog verbally as soon as it lays on the bed.
- 3. Leave the room for 2 seconds, then come back.
- Repeat leaving the room for random periods of time: 5 seconds, 30 seconds, 4 seconds etc.
- 5: If your dog stays on their bed, do nothing, but if they leave, send them back to the bed and start stage 4 again.
- When you can leave the room for 4 minutes without the dog leaving their bed, move on to stage 5.

Teach your dog to stay on their bed when you leave the room and close the door

- Send your dog to their bed and leave the room, the first few times touching the door when you go.
- 2. Now when you leave, close the door leaving it ajar. Repeat several times.
- 3. Now leave the room, close the door for 2 seconds and enter the room again.
- 4. If the dog remains on their bed, ignore them. If they move, start stage 5 again.
- Finally, leave the room, close the door and stay out for random periods of time.Enter and ignore the door if it has remained in its bed.











TOP TIPS TO MAXIMISE YOUR SUCCESS!

When at home with them, leave the dog alone sometimes.

Always give your dog something to do when you leave: a well-stuffed frozen KONG with tasty treats.

Your dog should sleep on their own bed at night and even better if not in your bedroom.

Be patient and calm.

Whatever you do before you go out (e.g. pick up your keys), do this often throughout the day

Socializing Your Dog

Remember: EXPOSURE alone isn't socialization!

If your dog isn't having a great time, you could do more harm than good. Dogs don't just "get over" issues by themselves, so if your dog is shy, worried, or overly excited, leave the situation and work with a professional who can help both of you. If your dog is having a blast and is happy and comfortable, you're doing a great job of socializing him!


