

My Sheltie, Ace, (MACH Starfall39 Gamblers Last Play UD) qualified for and participated in the AKC National Agility Championships in Tulsa, Oklahoma. (NAC). To be eligible for this event dogs needed 7 double Q's and 550 points in the qualifying period from December 1- November 30. On March 14 at 5 a.m. Ace and I, five dogs and four adults happily departed for Oklahoma, a 10 1/2 hour trip. All of the dogs were great travelers.

The NAC event began on Friday, March 15 -17. We celebrated St Patrick's Day there. There was a lot of green displayed that day.

Over this three day period there were 4 runs, Premiere Standard, JW, Standard, and Hybrid. Premiere was used as a practice run for Ace. In order to advance in standings, a dog needs to have a clean run (no mistakes). Then the dog's time is calculated. And rankings are chosen. In the final results, Ace had 3 out of 3 clean runs. He ranked 37 out of 187 qualifiers. Not bad for a 9 year old dog making his 1st appearance at Nationals!

Three changes to the Obedience Regulations were approved by the AKC Board of Directors at the February 8, 2019 meeting. The following amendments (underlined) to the Obedience Regulations were approved, which are effective for all trials held on or after August 1, 2019. An insert for the Obedience Regulations amended to May 1, 2018 will be published.

#### They are in summary:

- 1. Modify the Open B Point Schedule
- 2. Earning OTCH points outside of the Point Schedule in Open B & Utility B
- 3. OTCH title recognition

## **OBEDIENCE REGULATIONS CHAPTER 8 - OBEDIENCE TRIAL CHAMPIONSHIP**

**Section 2. Championship Points.** Obedience Trial Championship points will be recorded for those dogs that have earned a first, second, third or fourth place ribbon competing in the Open B or Utility B class, according to the schedule of points established by the AKC Board of Directors. When counting the number of eligible dogs in competition, a dog that is disqualified or excused from the ring by the judge will not be included.

One (1) Championship point will be recorded for those dogs that earn a qualifying score of 197 or better in the Open B or Utility B class, if they did not earn points based on the Point Schedule.

Requirements for the Obedience Trial Champion are as follows:

The dog must have won

- 1. 100 points
- 2. A first place in Utility B with at least three dogs in competition
- 3. A first place in Open B with at least five dogs in competition
- 4. An additional first place under the conditions of 2 or 3 above
- 5. All three first places under three different judges

Only one of the required first places may have been won at a specialty Show or a Junior Obedience Showcase.

**Section 3. Obedience Trial Champion Title.** The AKC will issue an Obedience Trial Champion certificate and will permit the use of the letters OTCH preceding the name of each dog that meets the requirements.

The letters OTCH will be followed by a numeric designation indicating the number of times a dog has met the requirements of the OTCH title as defined in these regulations (OTCH2, OTCH3, OTCH4, etc.).

#### **SECRETARY'S REPORT**

The minutes of the General Membership Meeting of November 16 were read and corrected. A motion was made by Liz Hixon and seconded by Bette McMillan that the minutes be accepted as corrected. (West Suburban Bank was reported as Suburban Bank.)

#### PRESIDENT'S REPORT

- 1. Jim Clarke reported that at the October meeting the topic of reducing the number of Matches, was discussed.
- 2. Our annual rent remains the same in spite of eliminating two matches per year. This is equivalent to a 4.3% increase in our daily rental.
- 3. Our Tuesday-night Matches will now be held in April, May, September and October.

#### **VICE PRESIDENT'S REPORT**

- 1. Laura Setar reported that our 2019 membership decreased by 15.
- 2. Laura compared the income between the membership roles of 2018 and 2019.

Even with the decline in membership, a total of \$130 more was received in 2019 than 2018.

3. Laura reported that the names of Virginia Hall, Clara Luke, Helen Baloun, Benita Pheleen, and Veronique Kuhlman were recommended for membership. A motion was made by Karen Schlipf and seconded by Marytherese Marosits, that the five named people be accepted into membership. Motion carried.

#### TREASURER'S REPORT

- 1. Donna Eichman reported that our Fiscal Year runs from December 1 to November 30.
- 2. Our year ended at \$9,107.34 in the red.
- 3. We did our last double ring trial Agility Trials in 2017; our income was \$10,938.89. Due to raise in facility rental & drop-in entries, we went to single-ring Agility Trials in 2018. Income for the three, one-ring trials in 2018 was \$6,999.77, which is a difference of \$3,994.12
- 4. Our expenses exceed our income with, awards, Monday night classes, obedience and tracking.
- 5. Although we aren't spending unnecessarily we will review our spending and see where we can do better. We need to concentrate on improving Monday income, running lean, don't buy what we don't need.
- 6. We definitely need to spend less and earn more.

#### **DIRECTOR OF TRAINING**



- 1. Liz Hixon indicated that she is going to create a questionnaire to send out to the membership and hand out on Monday to non-members. She said it will be a simple questionnaire just asking what changes people might like to see, what they don't like, and why they are coming to Glenbard.
- 2. It was also suggested by Ray Heitz that we have a "Suggestion Box" on the sign-in table. Jim will look for the one used previously.

- 1. Karen Heitz reported that she bought \$70 worth of supplies on the Internet.
- 2. She also reported, that while it only has one puppy, the Puppy Class is doing good. Both Beginner Classes are equally strong.

- 1. Jim Clarke reported that the awards are ordered and are ready for pick-up. He ordered 66 title plates and 5 plaques.
- 2. Laura Setar reported that so far there are only 11 people signed up for the banquet. She has arranged for a sweet table so anyone wanting to bring a dessert is encouraged to do so.
